#### 1. EcoProcura 2009: Climate Neutral through Procurement – Conference outcomes

**Reykjavik**, **25-27 March 2009** – Sustainable public procurement is a key tool in tackling climate change. This was the message given by more than 220 delegates from 41 countries at the 7th EcoProcura conference in Iceland's capital.

Public authority delegates pledged to use their vast economic purchasing power to help fight climate change, by strongly boosting the market for climate friendly products and services. Participants also called on national governments to put the issue firmly on their agendas in the decisive round of global climate negotiations that are

to take place in Copenhagen later this year.

The financial crisis has hit Iceland hard but both the City of Reykjavik and the national government are now forging ahead, using sustainable purchasing as a sound basis for a sound future, providing an excellent host for EcoProcura 2009. This commitment was reinforced by the signing of the new Icelandic sustainable

procurement national action plan at the event by the Ministers of the Environment and Finance.


Delegates were encouraged to "think globally and act locally", which, according to Iceland's Environment Minister, Kolbrún Halldórsdóttir, "is the mantra that will lead us to a more sustainable society". With over 2 trillion Euros spent on goods and services by public authorities in the European Union alone, the economic potential to push for sustainably innovative technologies and product solutions by local governments and all public bodies is enormous. However, it is only by combining and co-ordinating strategies and actions taking place at the local, national, European and international levels that this potential will be reached.

Demonstrating to budget-conscious public authorities that sustainable procurement is efficient procurement was highlighted as a priority. Promoting the greater use of life-cycle costing and finding the most efficient ways to meet real needs were presented as key in achieving this. The City of Vienna presented the most striking example, boasting savings of €43 million over 4 years, as the direct result of their sustainable procurement activities.

The highly interactive conference programme, also including training sessions, was designed to maximise opportunities for in-depth discussion and networking, and was much appreciated by participants.



#### SMART SPP moves into early market engagement phase



Seven months after the official start of the European SMART SPP project – innovation through sustainable procurement - activities are well underway in the project implementation phase, following the end of the second partner consortium meeting at the end of March in Reykjavik. The implementation phase will promote the introduction of new, innovative low carbon emission technologies onto the European market.

In May 2009, the project partners will publish a European Prior Information Notice (PIN) presenting the (purchasing) demand identified for public lighting systems – for example, LED lighting, OLED-lighting, lighting tubes - highly energy efficient (electric)

vehicles (passenger and duty cars), innovative ICT equipment, and construction services - for example, heating and cooling systems using renewable energy sources.


Sustainable Procurement team has embarked on a new project in partnership with the Ökoinstitut in Germany on promoting GPP in Germany. The two organisations have joined forces to develop, organise and carry out a series of training sessions on sustainable procurement to be held in five urban clusters across Germany. The training sessions will be geared towards public authorities in Germany, with a particular focus on procurers working in local and regional government administrations.

Individually tailored training seminars will be put together by integrating existing knowledge and training approaches developed through previous studies sponsored by the German Federal Environment Agency, and by drawing on the Ökoinstitut and ICLEI's experience.

The goal of the training sessions is to equip public authorities with knowledge and approaches to practically implement green procurement strategies and promote the approach in their own administration.

#### Governments of the City and State of São Paulo launch protocol on sustainable timber



On 18 March, the Governments of the City and of the State of São Paulo (Brazil) launched a protocol of intentions that recommends the use of sustainably certified timber in the construction of buildings - another initiative by the City and the State in favour of sustainable procurement. Recently, the City of São Paulo started replacing some of its motorcycle courier services with so-called 'bike-boys', in order to reduce local CO<sub>2</sub> emissions. The first meeting of the signatories of the protocol will take place on 17 April in order to implement the document's objectives. A second edition of the Guide "Timber: Sustainable Use in Building Construction" (Madeira: Uso

Sustentável na Construção Civil), revised by the Brazilian IPT (Institute for Technological Research) will also be launched at the event.

Both the State and City of São Paulo are partners in the international project "Fostering Sustainable Procurement in Brazil" (CPS-Brasil), coordinated by ICLEI's Latin American and Caribbean Secretariat. The project has an important capacity-building component that has jointly been developed by ICLEI's Sustainable Procurement team (in Europe) and ICLEI's office in Brazil.

#### **Biofuel Cities hosts session at World Biofuels Market**

Representatives of several stakeholder groups attended the session which was moderated by Eric Van den Heuvel, initiator of the project and Senior Consultant at Ecofys International. The presentations were based on two recent publications by Biofuel Cities: the Policy Handbook and the Sustainable Procurement Guide. The value of these publications was demonstrated by linking them to practical examples in presentations from the City of Stockholm and Graz.

## Buy IT Fair - new guidance on sustainable procurement on computers

The new guide "Buy IT Fair – Guide on socially and ecologically responsible procurement of computers" is available now in German. The guide provides guidance on how to include social criteria into public procurement tenders of computers, outlining the opportunities to include sustainability criteria in the various procurement phases.

## Procura<sup>+</sup> Seminar and participants meeting, 22-23 October 2009, Zürich


