1. Addressing the challenge of energy efficiency through smart technologies - Call for good practice!

Following the European Commission's recent Communication on mobilising Information and Communication Technologies (ICT) to facilitate the transition to an energy efficient, low-carbon economy,

the Commission has embarked on a European research and dissemination project to inform and provide guidance on the relevance of ICT to achieving energy efficiency and sustainability objectives at regional and local government levels.

The project has been commissioned by the Commission's DG Information Society and Media (INFSO) in collaboration with the EU's Committee of the Regions, and focuses on local and regional initiatives for promoting energy efficiency through the direct and enabling roles of ICT. Areas of interest include:

- ICT infrastructure and equipment/devices (e.g. purchasing energy efficient desktop computers, data centres)
- ICT enabled buildings/construction (e.g. planning and design applications, smart office lighting, smart metres)
- ICT enabled transport (e.g. road user charging, logistics systems, electric vehicles), and
- ICT enabled monitoring, measuring and reporting systems (e.g. carbon management systems, wireless sensor networks)

The project involves a review of examples of initiatives from across the European Member States. A toolkit will be prepared for local and regional authorities including guidance and a series of case studies. A wiki style website resource will also be set up to provide increased access to the results of the project. The project is being undertaken by an international team led by SQW Energy in partnership with ICLEI, the Regional Environment Centre (REC) and Intellect (the UK's national industry trade association for technology including ICT).

Update on SMART sustainable public procurement

Encouraging innovation through procurement – SMART SPP Guide and Tools available in English, Portuguese, Spanish and Danish

Public purchasers aiming to be a step ahead of their energy and climate change targets can consider using their procurement procedures to further support the development of sustainable innovative technologies, and at the same time, keep financial costs at a minimum. The two principal outcomes from the SMART SPP project, in terms of supportive guidance, have been developed with this intention in mind, and are both now available online for use by procurement practitioners.

The project outcomes consist of a Guide, which presents a standard procedure designed to encourage innovative energy efficient solutions. It has a strong focus on the ins and outs as well as on the benefits of procurers actively engaging with the market (that is, suppliers and producers) before tendering takes place. Innovative, energy efficient solutions are technologies which meet the needs of the purchasing authority and are highly energy efficient.

The Guide is accompanied by a Tool (in Excel format, supported by a User Guide) that is designed for procurement decision makers to calculate the life cycle costs (LCC) and CO_2 emissions of different
products and services.
All materials are all available in English, Spanish, Portuguese and Danish and can be downloaded at www.smart-spp.eu/guidance.
Both the Guide and the Tool are beta versions, which are to be
finalised in early 2011 following their use by the SMART SPP public authority partners in their innovation focused public procurement actions.

Encouraging greater early market engagement between public procurers and suppliers in the pre-procurement phase is essential to benefiting from what the market has to offer. That is why countries such as Spain, Portugal, the United Kingdom and Denmark (and soon Austria) are now using pre-procurement methods to purchase local police (electric) vehicles to LED vending machines.

SCI-Network – Sustainable Construction and Innovation through Procurement

The SCI-Network has been set up to bring together forward-looking public authorities from across Europe to drive sustainable innovation in the procurement of public construction works.

The network will be initially establishing three online working groups to examine good practice and future market developments in specific areas. A shortlist of potential topics has been drawn up with a final decision to be taken within the next few weeks:

- Sustainable renovation of school buildings
- Developing a business case for sustainable construction life-cycle costing (LCC) or whole life costing (WLC)
- Sustainable renovation of social housing
- Sustainable renovation of office buildings
- Sustainable renovation of historical buildings
- Sustainable insulation materials
- Sustainable road construction materials
- Innovative roofing solutions
- Integrating renewable energy systems into buildings

Additionally, a number of online discussion groups will be set up to look at certain key issues, such as construction procurement methodologies supporting innovation, and financing solutions for energy efficiency improvements.

Helping public authorities purchase energy -efficient products through Euro-Topten Plus

The Euro TopTen Plus project draws on the success of the www.topten.info website, which lists the most energy efficient products across Europe. The site allows for easy comparison of the energy efficiency of consumer items such as cars, household appliances, lighting and office equipment.



ICLEI is working to 'translate' the technical criteria used for the selection of TopTen for use by public sector procurers. The result will be reference specifications and award criteria which can be used directly in tender documents. This will extend the reach of the website, which has so far been aimed primarily at private consumers.



ICLEI is currently identifying public authorities interested in using the criteria in their own procurement activities, and preparing case studies based on these experiences.

ICLEI's Procura⁺ Campaign welcomes World Economy, Ecology and Development (WEED) as the new National Partner for Germany.



SPP focus session taking place at 6th European Conference on Sustainable Cities and Towns, 19-21 May, Dunkerque, France

The sixth conference on Sustainable Cities and Towns in Europe will explore how sustainable development can help local governments to face the current economic, social and

climate challenges. More than 1,500 local government leaders from across Europe, as well as their representatives from European and national networks of local governments, European institutions and NGOs are expected to take part in the conference in Dunkerque this year.

How can local governments make strategic use of their purchasing power to improve urban sustainability? Can sustainable public procurement result in more efficient and cost-effective public services? How can local governments be sure that the products they are purchasing have been produced under legally sound conditions? Some 300 international, national and regional public procurers are expected to take part in the final conference of the Public Procurement

The pro-EE project aims to improve energy efficiency through SPP by focusing on innovative products which yield higher economic and technical energy savings. Model SPP procedures and networking approaches, which can be implemented by any public authority in Europe, are also being developed through the project.

2	Responsible purchasing in Central America
	Comprasresponsables.org strives to create a community of experts in Central America to enable capacity building and exchange of experiences which will in turn be used to encourage public

administrations to consume sustainably, and develop tools to assist them in their implementation activities, such as educational materials, training and a 'green' product and service directory. Supported by the International Union for Conservation of Nature (IUCN), the project is run by CEGESTI, a Costa Rican NGO, and currently focuses its efforts in Guatemala, El Salvador, Costa Rica and Panama.

Since the project began last year, CEGESTI have provided training to more than 200 public officials in the focus countries. They have also provided technical assistance to several public administrations, in order to assist them to define and implement GPP policies. A couple of local governments in Costa Rica can already speak about their success stories; the Municipality of Santa Ana enacted their GPP policy in January this year, which includes eight lines of action to gradually implement GPP (including an information component to the community). Following Santa Ana's example, the Municipality of Tibás began the process of defining its policy and guidelines with the aim to have a council decision on GPP in place in the near future.

Despite not having legislation explicitly stating that the public sector must consider sustainability criteria when purchasing, CEGESTI's experience so far has been that the vast range of environmental legislation in the region is supportive of organisations working in this direction. Convincing (political) leaders that purchasing sustainably is the way forward is therefore instrumental to lock in their support.
