#### 1. Verifying Social Responsibility in Supply Chains-new guidance available

A practical and legal guide on social considerations for public procurers has been produced within the LANDMARK project. The overall aim of the project is to enable European local authorities to act as drivers for the promotion of fair working conditions in global supply chains.

Verifying Social Responsibility in Supply Chains analyses different instruments of verification that can be used at the various stages of a procurement process.

The guide demonstrates how verification schemes

can be applied in a legally compliant manner by

citing case law, providing examples of verification schemes developed and implemented across Europe, and by discussing the monitoring and measuring of compliance. One such measure is a bidder declaration, whereby a self declaration is submitted by the bidder to verify compliance with certain (social) criteria. This is quite common in Germany and model bidder declarations are included in the guide. Follow-up questionnaires are used by many municipalities in Sweden. The included 15-point-questionnaire is targeted at assessing the knowledge of working conditions of contractors along the supply chain.

A method which is not a formal part of the procurement process yet has been proven useful in the Netherlands is transparency and disclosure of the supplier and sub-contractors. This allows for NGOs and other civil society organisations to come forward with information they may have relating to compliance with required social standards. In Switzerland, bidders are asked to provide documentation proving that they comply with ILO core convention labour standards. For high risk products, an external audit is conducted - this very reliable tool requires substantial resources however, and cannot be transferred to the EU without additional modifications. A catalogue which includes a number of measures and means of verification for sustainable procurement of computers and textiles that was developed in Austria, is also included.

The use of labels, multi-stakeholder initiatives and codes of conduct to assist with verification of compliance with social criteria is presented with a number of practical examples. Finally, some sector-specific schemes relating to timber, construction materials and textiles are also discussed.

A good practice collection of a number of verification shemes used throughout Europe has also been published by the project. This series of case studies describes how organisations from different countries have approached the verification of social criteria at various stages of the tender process. Each study looks into how the compliance of direct suppliers is monitored and how this applies to the rest of the supply chain. It is hoped that procurement professionals and other key stakeholders will be able to use the experiences of their counterparts to develop or improve verification systems in their own authorities.

The legal guide and the good practice collection will be used in trainings for procurers and trainers in Germany, Portugal and Spain and will be presented at EcoProcura 2012. At the EcoProcura conference there will also be an interactive multimedia-stand demonstrating social aspects along the supply chain.

Translations in German, Catalan, Spanish and Portuguese are also available or will be so shortly.

## Strengthening the uptake of SPP standards in emerging economies

With the support of the Swiss State Secretariat for Economic Affairs (SECO), the ISEAL Alliance – the global association for social and environmental standards - has started a three-year project to strengthen the uptake of sustainability standards in sustainable public procurement in emerging economies. The objective of the project is to work closely with governments around the world, specifically in emerging economies, and help them to increase the scale, scope and effectiveness of their sustainable public procurement (SPP) efforts through the better use of sustainability standards.

As part of this project, ISEAL in collaboration with ICLEI – Local Governments for Sustainability, has conducted a series of interviews with a global range of public sector entities. The purpose of these interviews is for ICLEI to undertake field-level research to assess the extent and manner in which sustainability standards, such as eco-labels, are being used by public sector officials to support SPP.

These interviews will feed into a baseline report on the current use of sustainability standards in SPP around the world. When completed it is anticipated that this comprehensive report will reflect the current global status, successes, needs and challenges faced in the use of sustainability standards in SPP policies and procedures.

#### Purchasing the most energy efficient products on the market - Euro Topten Max

Euro Topten Max is a follow on project from Euro Topten Plus, aimed at facilitating the purchase of the most energy efficient products on the market. Topten is a consumer-focused online search tool, which presents the best appliances in terms of energy efficiency, impact on the environment, health and quality. Seventeen European national Topten sites have so far been established. National websites in the United Kingdom and Croatia are now well underway and should go live later this year.

Topten caters for large-scale procurement professionals as well as individuals through a

specific Topten Pro webpage which contains sample tender documents and procurement guidance for a number of product groups. This guidance includes potential cost and energy savings, example technical specifications and award criteria. Topten therefore not only serves as a powerful instrument to raise public awareness on energy use, but also as a means to drive sustainable procurement by promoting transparency and influencing manufacturers.

A number of sections on national websites are planned and will be tailored to the Topten specifications developed by European countries. As part of the Euro Topten project, ICLEI is coordinating a pilot scheme to find six European local authorities to use Topten criteria in their tenders in order to demonstrate potential cost and energy savings.

Topten product criteria are continually revised, as inefficient products used for comparison are made obsolete and new, highly energy efficient products enter the market. Updates to all technical criteria and sample tender documents on the European Topten website have now been made and will be released imminently. Procurement guidelines for a wider range of product groups will also soon be available.

#### Procura<sup>+</sup> Participants' and National Partners' Meeting

The Procura<sup>+</sup> Campaign will hold its Participants' and National Partners' meeting on 19 September 2012 before the start of EcoProcura in Malmö (Sweden). The meeting will take place between 9.30 and 11.30am, just before the start of the conference.

One of the main objectives of the gathering will be to finalise the Campaign's Action Plan as a group. There will be the opportunity for an exchange of information and good practice between Procura<sup>+</sup> Participants, National Partners, ICLEI and others on socially and environmentally responsible public procurement. Newer participants will also briefly report on the progress their organisations have made to date on SPP.

#### Three new members join the Procura<sup>+</sup> Campaign

The City of Gent (Belgium), the City of Turku (Finland) and the Region of Brussels (Belgium) are the latest additions to the Procura+ Campaign, joining cities from across Europe and beyond in the drive towards sustainable public procurement.

In 2008 the City of Gent introduced an action plan for sustainability, titled Gent 2020. Before 2020 more than 105 actions and projects will be implemented. This includes a sustainable procurement strategy centring on strategic procurement, with an additional focus on sustainable return on investment.

The City of Turku is currently implementing a long-term strategy for sustainable development with a strong emphasis on sustainable public procurement. By applying environmental criteria for their lighting and office equipment Turku expects to reduce its electricity consumption by 50 percent.

The Region of Brussels has organised general and specific training sessions on SPP. They also developed a network of Brussels green public procurers, which includes four training workshops per year and a website which centralises all relevant information about green procurement, in particular green procurement in the Region of Brussels.

#### Annual SCI-Network meeting & EcoProcura 2012

The next Annual SCI-Network (Sustainable Construction and Innovation through Procurement) meeting will take place on 19 September 2012 in Malmö (Sweden) – directly before the EcoProcura conference.

The meeting will focus on the presentation of a new SCI-Network Guide for public authorities to assist them in procuring innovative and sustainable construction solutions. This guide will be the culmination of the wide consultation round on the draft recommendations developed by the Network's five working groups. The meeting will provide an opportunity for public authorities to share their experiences in sustainable and innovative construction procurement.

#### Training on sustainable timber procurement

Training seminars for public authorities on sustainable timber procurement will be organised in six European countries between October 2012 and June 2013. The seminars will take place in Romania (October), Italy (November) Spain (November), Germany (December), Estonia (April), Hungary (June). Further seminars for SMEs in the timber sector will be organised in Romania, Estonia and Hungary in the same months.

The seminars are being organised by the Sustainable Timber in Action project, and are to be based around the sustainable timber procurement guide due to be published in August.


