# 1. EcoProcura conference highlights strategic potential of sustainable and innovation procurement

	After three days of exciting exchange, delegates at the EcoProcura conference
222	in Ghent (Belgium) concluded that for Europe to gain maximum benefit from
	procurement practices, sustainable and innovation procurement must be
	placed at the heart of strategic decision making. The European Commission's
	revised Public Procurement Directives will play a significant role in harnessing
	the immense capacity of the public sector to foster sustainable and innovative
	solutions, and move procurement from being seen as an administrative to a
I	strategic concern.

The conference, organised by ICLEI and the City of Ghent, demonstrated the consensus that the pressing issues facing Europe today require public authorities to work with the market to develop sustainable and innovative solutions, rather than viewing the market as unchangeable.

At the close of the event, the City of Ghent demonstrated its commitment to sustainability by signing a strategy on sustainable procurement and a Charter that obliges the city to spend 10 percent of its ICT budget on innovative solutions.

Daniël Termont, Mayor of the City of Ghent, said: "We are proud that ICLEI has chosen Ghent as the host city for its EcoProcura Conference. Sustainability is in all that we do, exemplified by our aim to achieve a climate neutral city by

2050. Moreover, Ghent wants to be a 'smart city' that employs creative solutions to everyday problems, and unites citizens to learn from one another. Ghent is a firm believer in the important role procurement plays in making our city more sustainable and in obtaining innovative products and services."


#### Topten releases guidance for four new categories

The Topten project has released guidance for four new product categories. Advice and sample tender documents give practical assistance on procuring the best value and most energy efficient appliances available on the European market in LED Classic Lamps, LED Spots, Dishwashers and Office Luminaires.
These accompany the six sets of procurement guidelines already published on the Topten Pro section website for a range of other product categories including computer monitors, imaging equipment and vehicles. A series of case

studies on how public authorities have used Topten criteria to save money and energy will soon also be available on the Topten Pro section of the European Topten website.

## 'Healthy ageing' solutions sought in tender published by European health care providers

Six health care purchasing bodies from five European countries have published a competitive tender, inviting companies to propose products and services that will aid the elderly. The solutions sought include a fall detection and alert system; a treadmill for rehabilitation and analysis of walking disorders; a walking course for preventing falls and maintaining independence; a bed thermoregulation system; and a chair enabling users to maintain independence, reducing effort for aides.



Notice of the competitive tender was published in the European Union Official Journal on 30 September 2014 by the organisation RESAH, coordinator of the HAPPI project (Healthy Ageing - Public Procurement of Innovation). The specifications are available in three languages: English, Italian and French. Bids can be addressed in any of these three languages, however the application documents must be provided in French only.

A Helpdesk in English and Italian has been created to support bidders with the application process, especially small and medium enterprises. The helpdesk provides information on how to create an account and download the HAPPI tender documents, how to ask a question on the FAQ page, as well as information on how to upload an offer to the platform.

#### Eight new case studies published by GPP2020 project



GPP 2020 aims to mainstream low-carbon procurement across Europe in support of the EU's goal to achieve a 20 percent reduction in greenhouse gas emissions, a 20 percent increase in the share of renewable energy, and a 20 percent increase in energy efficiency by 2020.

A core aim within the GPP 2020 project is to tender and contract low carbon products, works and services. Through these tenders CO2 emissions are reduced and a more energy efficient economy is encouraged. To achieve long

term sustainability, the tenders need to be replicable for other local authorities interested in making their procurement greener.

In line with this, each tender issued by one of the GPP 2020 partners is documented as a 'tender model', using a case study format. These tender models are easily accessible through the project's searchable tender database. Eight new tenders have been published, with more to come.

#### Innovative catering – Resah publishes PIN for biodegradable dishes

INNOCAT partner Resah-idf (réseau des acheteurs hospitaliers de l'ile de France) have published a Prior Information Notice (PIN) providing details of their upcoming tender for eco-innovative food containers and associated recycling services. Three lots will be included in the tender, one of which is for 'biodegradable and compostable dishes'. The containers will be required to meet EU standard EN13432 and must be able to be disposed of as organic waste.



The tender forms part of Resah's plan to reduce the environmental impact of consumption, while meeting the current budgetary constraints of its 130 members. An invitation to tender is due to be published in the next few weeks, with each lot being offered for two years.

## **ENIGMA lighting PCP – events and exchanges**

	Innovative Lighting Solutions. The session also included presentations from
	Lieve Bos from DG CONNECT at the European Commission on Innovation
	Procurement in domain of City Lighting - An opportunity for cities and regions
	and Dr. Leon Smith from Transport for London who presented the Pro-Lite
	project. All presentations are available here.

On October 2, a webinar on Innovative Public Procurement took place as part of the ENIGMA project. The webinar included presentations from Vasileios Tsanidis from the European Commission who presented An introduction to innovation procurement and the EU financial support for PPI and PCP, and Caterina Sampol from AQUAS, Barcelona who presented Cities innovating through pre-commercial procurement. Both presentations as well as the webinar itself are now available online.

Finally, a study visit focusing on the inspiring qualities of light and the potential economic and social benefits that interactive light displays and light festivals can have will take place in Eindhoven (the Netherlands) from November 12 – 13 as part of the ENIGMA project. The study visit will take in the acclaimed GLOW festival, and will provide an opportunity for public procurers to discuss the topic of innovative public lighting with other interested stakeholders. Following the study visit, select participants will have the chance to take part in a one and a half day "work shadowing" event within the City of Eindhoven, providing a unique opportunity to gain insight into the inner workings of a pioneer city and to exchange with a range of professionals. A maximum of two representatives from public authorities will be able to take part in this work shadowing. An agenda is available for the event, and registration is possible online. ## New project PRIMES - providing hands-on support for public purchasing organisations with green public procurement

The purpose of the PRIMES project is to develop basic skills and provide practical support for public purchasing organisations to overcome barriers and implement Green Public Procurement (GPP). Many lack capacity and knowledge; particularly small and medium sized municipalities. PRIMES will demonstrate how such support can be delivered at conditions which are favorable for even the smallest purchasing organisations; by sharing and co-operating; or by working with a regional energy agency, a cluster organization or the regional authorities.



By developing skills and capacity in a large number of these small and medium sized organisations, PRIMES will have high leverage. Task forces of experts will work with purchasing organisations on specific contracts. There will be at least 114 procurements across 6 partner countries: Denmark, Sweden, Latvia, Croatia, France and Italy. It will be a "learning by doing" process to draw up tender specifications and evaluation criteria which will deliver better products and services. ## Water PiPP - Gathering information via thematic working groups

	Water PIPP is exploring new public innovation procurement methodologies and testing them in the water sector, in a context where European innovation potential is often blocked by a number of bottlenecks. Water PiPP aims at facilitating real innovation, mobilising public authorities, public and private purchasers, water utilities, networks of cities and regions, the research and innovation community in the field of water, the supply side (especially SMEs) and many more.

Launched in January 2014, Water PiPP is now in its first phase gathering information to produce knowledge on innovation procurement's transferability to the water sector. The second phase will focus on pilot cases where different innovation procurement approaches will be tested by public procurement authorities.

Currently Water PiPP is setting up working groups for cities, regions, public operators, industries and water authorities. Participants will be able to test their ideas on innovative procurement procedures with a group of specialists from all over Europe to better understand and get inspiration on how to access latest solutions in water technologies and services to contribute to shaping future European policies for procurement that can facilitate the uptake of more sustainable solutions in urban water management.

#### Call for hosts - Procura+ Seminar 2015

In particular, the seminar will explore how to successfully combine efforts towards innovation and sustainable procurement and using these synergies to reach strategic climate goals.

#### Rotterdam's ambition to become the world's most sustainable port city

Europe's largest international port and the second largest port in the world, Procura<sup>+</sup> participant Rotterdam takes its responsibility for promoting a sustainable city seriously. A clean, green and healthy city where sustainability contributes to a strong economy - this is the ambition Rotterdam wants to work on with its new Rotterdam Sustainability Programme. Reducing carbon emission by half, preparing for the consequences of climate change, improving air quality and reducing noise are the main topics of the programme. The Municipality will invest 31 million Euros in order to achieve the green ambitions.



The so-called 'Green Deal 010 Zero Emission City Logistics' sets the target to have an emission-free freight transport in the inner city by 2020, by means of electric, hybrid or bio-gas vehicles.

October 2014, a new Procura<sup>+</sup> participant has been welcomed to the mpaign. Cornwall Council has developed a new Responsible Procurement licy which outlines its commitments to ethical sourcing, environmental stainability and carbon management.

one of many examples, Cornwall Council is committed to purchasing timber m sustainable sources. For many years a majority of the Council's timber rchasing has been Forest Stewardship Council (FSC) accredited, however ere was a lack of effective monitoring. Since early 2012 the Council has been working closely with the World Wildlife Foundation (WWF) to put these

monitoring procedures in place and has been awarded 'silver' under the WWF Sustainable Timber Campaign in 2013.

#### Ghent – EcoProcura 2014 and its Sustainable Procurement Strategy

The City of Ghent hosted the EcoProcura 2014 conference on 24-26 September 2014. Key themes for the 2014 conference included:

- Cost-efficient use of public money through procurement
- Developing integrated sustainable public procurement strategies across the organisation
- Implementing the new European Public Procurement Directives
- How public procurement can stimulate innovation, including the announcement of the Public Procurement of Innovation Award winner.



There was also a 'meet the buyers' event and several short training sessions. At the close of the event, the City of Ghent demonstrated its commitment to sustainability by signing a sustainable procurement strategy and a Charter that obliges the city to spend 10 percent of its ICT budget on innovative solutions.

## Celebrating ten years of of the Procura<sup>+</sup> campaign

	Prefacing the EcoProcura conference in Ghent, participants, national partners and interested public authorities came together for the annual Procura <sup>+</sup> meeting, talking about their successes and challenges in sustainable public procurement (SPP). More than 30 representatives from local and regional governments, utilities companies and expert organisations discussed prominent topics such as SPP monitoring, market engagement and the link to a circular economy.

This coincided with the Procura<sup>+</sup> Campaign celebrating ten years of connecting and supporting public authorities committed to SPP. Over the last decade, Procura<sup>+</sup> has supported over 150 public authorities in implementing SPP and promoting their achievements such as reducing CO<sub>2</sub> emissions or establishing fair trade principles. In 2004, Margit Vjestberg (Kolding, Denmark) and Imma Mayol (Barcelona, Spain) invited political leaders from across Europe to join a campaign to foster SPP. This happened at a time when SPP was becoming increasingly recognised as a beneficial driver for achieving local and regional policy and development goals, relating to climate change, urban expansion and smart mobility concepts, to name but a few.

Dozens of public authorities responded and joined Procura<sup>+</sup>. Beat von Felten, Procura<sup>+</sup> founding participant, reflects on this saying that "thanks to Procura<sup>+</sup> the City of Zürich has been able to position themselves as a leader in the field of sustainable procurement. Zürich appreciates the valuable exchange on good practice, news and especially enjoys the open discussions which take place on issues which naturally arise when an organisation decides to implement new approaches and procedures. Procura<sup>+</sup> offers the perfect frame to do this and, if needed, even offers tailor-made advice and support."


